

Instructions for Completing This Application

to receive flying privileges at Flying Club 1

Great! You like <u>The Deal</u> that Flying Club 1 is offering, and you're OK with signing the <u>Waiver of Liability</u> later in the application process.

Understand that the Club itself does not provide flight instruction. Once given flying privileges, you can use our airplanes for instruction. However, it will be your responsibility to contract with a Certified Flight Instructor approved by the Club, and pay them.

To apply for flying privileges:

- **Step 1:** Join Flying Club for \$20. You can do it <u>online</u>. To pay an instructor for instruction in our airplanes, you must legally be a member of the Club.
- **Step 2:** Fill out this Application Form electronically.
- **Step 3:** Make a PDF or JPG image of these other documents:
 - Driver's license (front only)
 - Airplane pilot certificate, if any (front only)
- **Step 4:** Create an account with Flying Club 1 in Flight Circle¹.
 - Go to this URL and create one. It's free. When you do, the Flight Operations Chief will get an email alerting us to your request.
 - When he opens the door, Flight Circle will send you an email. You can then go into your account and upload this application.
- **Step 5:** You will then schedule a meeting with an instructor (a *CFI*) that works with the Club. The Flight Operations Chief will help you with that.

Flying privileges will begin when you pass a checkride given by a Club-approved CFI. Or, if you're a student pilot, when your instructor endorses you to solo.

I understand that Flying Club 1, Inc. (the Club) reserves the right to not approve this application, for any reason or no reason.							
I have read and understand the Club's <u>Bylaws</u> and <u>Operating Rules</u> . I agree to abide them as well as by all rules and regulations of the FAA, the Virginia Department of Aviation, and the airfields at which I fly.							
I agree to sign the Club's Waiver of Liability later in the application process.							
I agree that I will not use club equipment for any commercial, business, or illegal activities.							
I agree to pay all assessed dues and fees as required by the club Bylaws and the Rate Sheet. in effect at the time they are due. I understand that failure to do so will result in loss of flying privileges.							
I agree to carry no passengers except those who have signed the Club's <u>Passenger Liability Waiver</u> . (Blank copies available in the hangar.)							

I understand that once I'm approved to fly solo, in order to keep my flying privileges I must buy and maintain a Non-Owned Aircraft insurance policy of the kind described in the <u>Rate Sheet</u>.

I understand that I am liable for any damages I may have caused to club equipment.

Working under the supervision of the Club's Maintenance Chief, I agree to fix any damage for which I am responsible, promptly and at my own expense.

I understand that the Club will refund my dues only if the Club revokes my flying privileges.

In particular, the Club will not refund my dues because its aircraft are down for maintenance, even if for an extended period. I accept this possibility as simply a risk that comes with the sport.

I understand that the Club does not provide flight instruction. I will be responsible for contracting with an instructor and paying for instruction myself. Further, because Club airplanes do not fly like Cessnas and Pipers (being low-mass, high-drag aircraft), I understand that only instructors approved by the Club may fly Club aircraft.

I understand that there may be a shortage of certified flight instructors willing, available, and approved by the Club to instruct in Club aircraft. The Club works hard to find such instructors, but will not refund my dues because I am unable to schedule instruction as much as I would like.

Notwithstanding the above, if I surrender flying privileges and find a replacement for myself, the Club will refund the pro-rated share of my annual dues.

I understand that I may terminate my flying privileges at any time via an email to the Flight Operations Chief. I agree that my resignation will not oblige the Club to refund me any dues already paid.
