ADVISORIES

March Meeting - Our March meeting was held in the Library/Media Center of the Centreville High School. Another group was holding a meeting in another part of the same room and their presentations made it difficult to hear our own speakers.

Dick Baker reported on the status of his new plane. It has been assembled, flown, and is ready for painting. He has been unable to find a paint shop here to do it soon so he will fly it to Atlanta for painting and then on to Chattanooga to its new home.

The Club Flying Leprechaun Library files have been moved from Larry Walker's hangar. They are in temporary storage in Tim Stormer's hangar until a new permanent location can be established.

Secretary Lew Clement reported that we have 60 '06 members. Twenty-nine '05 members have not re-upped as of the meeting. They have received their last Club roster and newsletter – until they become '06 members.

Treasurer Jim Birnbaum reported that, as of the end of February, our expenses for the month were \$15.24 and our income was \$133.00. Our current assets were \$4,978.88.

Larry Walker reported on the status of Whitman Strip with added information by Tom Richards.

Director of Safety and Training Jim Willess reminded everyone that scud running is a NO-NO! People get killed trying it and several have been killed that way recently. We had damage to a plane on landing last month. Watch your air speed and remember that there are sinkers at the approach end of Runway 04 at WAP.

Tom Richards announced that the main runway at the Air Park is mostly dry, with just a few muddy spots along the center line. Stay away from them. There will be a "Labor Day" at the Air park on March 25th, beginning at about 9 AM and lasting until mid-afternoon. He asked anyone who can help to join the party. Bring tools, chain saws, etc.

President Len Alt reported that there has been no response from the Flying Circus to his letter querying them as to their intent to invite Club 1 to join one of their Sunday air shows this year. We would like to know for scheduling purposes. Larry Walker and Chuck Tippett will be asked to follow up on this.

Len reminded all present that we still need an Events Coordinator to be the over-all coordinator for the year's Club activities. This member's responsibilities would be to assure that each individual

event had its own coordinator and to help individual activity coordinators arrange their event.

He reminded us that April's meeting would be at the Air Park on Saturday, April 8th, beginning at 11 AM. Jim Birnbaum has volunteered to coordinate this event.

There has been a proposal put forth that the Club make a fly-out to Sky Bryce this year. If there is interest in doing so, please let Len know and of a proposed date. Who would be willing to coordinate this event?

We were reminded that the annual Ultralight Safety Seminar at Richmond Airport would be on March 18th. Some members discussed the feasibility of flying down.

There was also a reminder that the annual Father's Day at Footlight Ranch, the biggest fly-in in our region, is coming up before very long. The weekend of 16-18 June, to be exact. We hope many members plan to attend, whether you fly or drive up. If you do attend, stop by the Volunteer Desk and volunteer to help, as members of all of the other clubs attending do.

Larry Walker told us that he and Jerry Starbuck were building a powder coating oven. They are looking for an old kitchen stove oven that they could use to bake the sprayed-on powder coating.. He told us a little about the process.

Lew Clement proposed that it might be time that we, as a club, visited the Udvar-Hazy Air and Space Museum at Dulles again. He suggested a Saturday, reminding us that it closes to the public at 5:30 PM and that the only charge for entry was \$12 per car, regardless of the number of occupants. Len asked Lew to recommend a date.

Jim Birnbaum reported on the status of his new plane.

As we were told at a past meeting, Dick Baker is moving to Chattanooga. We will, therefore, require a new Vice President. Dave Riedel nominated Tom Richards for that position. Those present voted him in by acclamation.

Jim Willess closed the meeting with a presentation on "Medical Factors", knowledge needed for the Sport Pilot Exam.

A VISIT TO THE WARRENTON AIR PARK

I hadn't been to the Air Park since last fall, for the last Club event we had there, until today, when I drove down to document the Work party. I hangar my plane at Warrenton-Fauquier so, despite trips there over the winter months, there had been none to the Air Park.

For those of you old timers who may not have visited the Air Park since last year and those of you who are new to our Club and never saw how the Air Park used to look, these comments may be revealing.

When I drove down Green Meadows Road to the right turn into the Air Park, I was looking for the slot in the bushes through which we enter the drive into the field. What I found instead was this wide open area with a sweeping drive through it. What was going on here?



As I entered this strange drive, I glanced to the right. In the past, there was nothing but more brush and, if one looked carefully, at the end of a drive in that direction, you might get a glimpse of a cottage shrouded by trees and bushes. Now, there it was – the cottage – clearly visible under some taller trees.



Driving through the gateway to the Air Park itself, now less shrouded in bushes, I noticed, in the field on the right, a huge mound of shrubbery cleared from along the roadway. And, looking to the left, I noticed I could see through the trees along the roadway and see the fields beyond them. And, looking further, I could see a house – one of the neighbors we knew existed but could never see before.



Arriving at the circular drive around the tall center tree, I could see the Club House (or Tom's residence, now) clearly, my vision of it no longer blocked by the hedge row through we had to pass to reach the house.

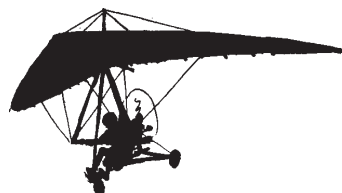
