Light Aircraft in Heavy Air

During the last club meeting, Tom Richards mentioned that there are spots on the airfield where you can get in trouble on days when there is some wind. That got me to thinking about some incidents and advice I've encountered over the years. I started flying very light aircraft about four years ago. I figure the wing loading on my trike is about 6 pounds per square foot. (In the jet I used to fly, that number was about 100.) Needless to say, I've developed a whole new appreciation for knowing what the air is doing, since my trike flies more like a butterfly than the jet-powered brick I was used to. In my transition to this new type of flying, one of the best pieces of advice I got was to visualize the air flow ahead of me. We've all seen eddies generated when water flows around a rock in a river. The same thing happens when air is flowing over trees or hangars followed by open terrain, like a runway. If the wind is blowing hard enough, the horizontal wind eddies that result are called rotors. Rotors caused by wind flow over mountains can be violent. I lost a good friend who flew a Navy jet trainer into one. In our light-loaded aircraft, much less wind over much smaller obstacles can cause downdrafts and rotors that can be dangerous. Knowing how the air is moving close to the ground is a matter of knowing the general wind and then visualizing what the air will do as it moves over or around obstructing trees, hills, and structures. During the middle of the day, thermal action will compound the air movement. I suggest you make it a normal practice to visualize the predictable downdrafts, rotors, and thermals when operating near the ground, and don't let yourself be surprised.

In flying a trike, the best way to stay out of trouble when landing near obstructions or with

thermals around is to accelerate into the flare. This technique should work for light-weight 3-axis aircraft too. When descending to land, at about 75 ft above the ground, I pull the control bar in which dips the nose and immediately adds 5-7 kts to my 50 kt speed. This is followed by a normal round-out and flare. In addition to having extra stall margin, the additional speed adds control and go-around responsiveness, and punches cleanly through any disturbed air near the ground. It is a good idea to do this regardless of expected conditions; a lesson I learned at Sky Bryce in the western Shenandoah Valley. The Sky Bryce airport is in a bowl. I merrily approached to land in what I thought were no wind conditions, and experienced a really ugly landing. (There is a windsock, you just need to know where to look!) The only thing that kept me from damaging the aircraft was the fact I had initiated a go-around several seconds prior to hitting the ground. As I reconstructed what happened, it became clear that despite the general no-wind conditions elsewhere, in that bowl there was at least 10 kts of air flow coming over the trees lining the runway, pushing an unsuspecting pilot into the ground. The bowl was generating its own air flows because of thermals elsewhere in the bowl.

When flying around Warrenton Air Park, be aware of air flows over the trees at the departure end of runway 04. A wind from that direction will have a downward vector after clearing the trees, which can threaten an aircraft taking off from 04 with marginal climb capability. Also, crosswinds from trees near the landing points of 04, 22, and 33 (both of them) can cause "sinkers," which have led to hard landings. PPG folks need to be especially aware of low level air movement around obstructions, as illustrated by the recent incident where a PPG pilot landed in the roof of the southern hangar.

Visualizing the air flows is one of the defensive flying techniques I've been emphasizing in the newsletter. It's just good piloting. Make it part of your flying routine.
