

# Flying Club 1, Inc. Articles of Incorporation

Amended and Restated in their Entirety, December 16, 2022 The list of Directors amended, January, 2024

The undersigned, pursuant to Chapter 10 of Title 13.1 of the Code of Virginia, states as follows:

### 1. Name

The name of the corporation is **Flying Club 1, Inc**. It is registered with the Virginia State Corporation Commission under number *05254321*.

## 2. Classes of Members

The corporation shall have two classes of members – voting and honorary - with such qualifications and rights as set forth in the bylaws.

# **3.** Appointment of Directors

The corporation shall have seven Directors. All are elected directly by the membership at a meeting in November or December of each year. Their terms commence immediately upon election.

- The President and Secretary serve two-year terms beginning in odd-numbered years.
- The Vice President and Treasurer serve two-year terms beginning in even-numbered years.
- Three Directors-at-Large serve one-year terms.

In the event of an unscheduled vacancy of an office, the Board of Directors shall appoint a member to serve until the next election of that office.

# 4. SCC Active Agent

The State Corporation Commission Active Agent is Fabian Georges.

# 5. Corporate Business Address

The corporation's business address is 7051 Brookfield Plaza #5322, Springfield, VA 22150. Fairfax County, Virginia.

### 6. Purpose

The purposes of this non-stock, non-profit, recreational corporation are to:

- 1. Promote and support light and ultralight aviation in Northern Virginia.
- 2. Promote safety among light and ultralight flyers in Northern Virginia.
- 3. Provide mutual support and encouragement to the members.
- 4. Represent the interests of light and ultralight aviation to the FAA and political authorities in Northern Virginia.

## 7. Membership

The Club is open to everyone who applies and pays dues.

The Club does not discriminate as to sex, color, race, national origin or religion.

#### 8. Revenue

Annual dues are the main source of income for the club. To join, voting members are required to complete an application form and pay dues.

#### 9. Tax Status

Under the rules in IRS Publication 557, this corporation would be considered a 501(c)7 recreational corporation, being non-stock and non-profit.
