



Flying Club 1, Inc.

Articles of Incorporation

Amended and Restated in their Entirety, April 7, 2012.

The undersigned, pursuant to Chapter 10 of Title 13.1 of the Code of Virginia, states as follows:

1. Name

The name of the corporation is **Flying Club 1, Inc.** It is registered with the Virginia State Corporation Commission under number 05254321.

2. Classes of Members

The corporation shall have two classes of members – voting and honorary - with such qualifications and rights as set forth in the bylaws.

3. Appointment of Directors

The directors shall be elected and appointed as follows:

- The President, Vice President, Secretary, Treasurer, and Immediate Past President shall be elected by the members as set forth in the bylaws.
- The two Directors-at-Large shall be appointed by the elected directors as set forth in the bylaws.

4. Registered Agent

The corporation's registered agent continues to be **James Birnbaum**. He is a resident of Virginia and a director of the corporation (Treasurer).

5. Registered Office Address

The corporation's registered office address – which is identical to the office of the registered agent – is 8570 King Carter St., Manassas, VA 20110

The registered office is in the city of Manassas.

6. Purpose

The purposes of this non-stock, non-profit, recreational corporation are to:

- a. Promote and support light and ultralight aviation in Northern Virginia.
- b. Promote safety among light and ultralight flyers in Northern Virginia.
- c. Provide mutual support and encouragement to the members.
- d. Represent the interests of light and ultralight aviation to the FAA and political authorities in Northern Virginia.

7. Membership

- a. The Club is open to everyone who applies and pays dues.
- b. The Club does not discriminate as to sex, color, race, national origin or religion.

8. Revenue

Annual dues are the main source of income for the club. To join, voting members are required to complete an application form and pay dues.

9. Tax Status

Under the rules in IRS Publication 557, this corporation would be considered a 501(c)7 recreational corporation, being non-stock and non-profit. The corporation's current Tax Exempt number is 54-1753421.
